- If any of the information supplied on this application by the applicant is found to be false, the fees and charges will be adjusted retroactively to the date of this application and appropriate fees and charges added to the next utility services bill for the address.
- Applicant understands that water usage in excess of the assigned Water Budget may result in significantly higher costs as an incentive to use water wisely.

Increased Water Budget and impact on wastewater charges:

The base Water Budget for indoor use is 12,000 gallons bimonthly. This is based on the average Highlands Ranch household population of 3 persons. Additional permanent residents over 3 may be the basis for an increase in the base Water Budget for indoor use of **3,000 gallons per person**.

However, the Wastewater Fee charged for the residence WILL BE INCREASED because it is also calculated based on a 3 person household. Using more water indoors means more wastewater will be generated. The following table shows the impact on the wastewater fee for your request for additional Water Budget. **Therefore, you may not have a net cost savings unless your household population is 5 or more.**

*** Important Note: The increase in the Water Budget for Household Population Adjustment purposes may not lead to any savings if your actual winter water usage is less than the AWB shown above. However, the increased wastewater charges will still be in effect. Therefore, if your actual winter time water use is less than the AWB, you could actually end up paying more in wastewater charges with no savings on water charges. For this reason you should carefully consider whether you really need this AWB.
